Throughout the first half of fiscal year 2019-2020, Renewal Inc. was successfully providing its high quality, comprehensive behavioral health and justice related reentry services to the communities it serves. Renovations of the new corporate offices and the construction for the new county-wide Engagement Center, now known as The Pathway to Care and Recovery and Safe Place to Stay located at 326 Third Ave., Pittsburgh, PA were well under way.

As we entered into the first few months of 2020 the COVID 19 virus entered a pandemic stage and life and work as we have known it was turned upside down. The challenges faced by Renewal to manage through this crisis while maintaining the health, safety and employment of everyone we serve and all employees were unprecedented in our history. Renewal immediately mandated full compliance to all national, state and local COVID 19 regulations and guidelines for sanitation, personal protection equipment and social distancing. Renewal was extremely fortunate to have qualified for COVID 19 assistance through the Federal Paycheck Protection Loan Program that made it possible for us to navigate through extreme program revenue losses without the need for service reductions or closures and avoid a workforce reduction.

With that said, the challenges remain each day but the vaccines for the virus are on the horizon and Renewal has faith that a "new normal" is ahead that will allow for a return to its ability to continue current programs and services, experience the long awaited full opening of The Pathway to Care and Recovery and Safe Place to Stay and to continue the strategic planning and development of needed service to the community.

OUR HISTORY

The Early Years

Renewal, Inc. was formed in 1958 through the efforts of Pittsburgh businessmen serving on the Penal Committee of the St. Vincent de Paul Society. The new organization is dedicated to returning adjudicated offenders to society as responsible citizens.

In 1976, thanks to the organization's successful and intensive focus on sustainable healing for individuals, Renewal, Inc. was incorporated as a private, non-profit organization. Its first Administrator was Thomas O'Brien, himself an ex-offender and reentrant of the program.

Building a Comprehensive Program

In 1988 Renewal expanded its services to include housing, opening a 25-bed facility in Homestead, PA to help mitigate overcrowding in the Allegheny County Jail. Almost 30 years later, Renewal and Allegheny County continue that relationship along with contractual agreements with a range of County, State and Federal entities. Today Renewal provides critical residential services for 627 individuals in two facilities owned and operated by Renewal, Inc. in downtown Pittsburgh.

Since the 1990s and early 2000s, Renewal has pursued and leveraged its contractual relationships to evolve into a service provider offering the most comprehensive programs in community corrections.

In 1997, because of increasing demand created by Renewal's growing capabilities, Renewal Treatment, Inc. was founded to perform inpatient and outpatient drug and alcohol treatment services.

Renewal consolidated its operations in 1995 when it purchased and renovated a facility located at 339 Boulevard of the Allies in downtown Pittsburgh. Through a robust renovation, this location now has a bed capacity of 374 and meets all standards of the Americans with Disability Act, American Correctional Association Adult Community Residential Services 4th Edition, Pennsylvania Department of Corrections and Federal Bureau of Prisons.

Though there are many success stories that have come out of the work done within RTI's Outpatient Mental Health Clinic, these successes have not come without struggle and setbacks. The clinicians at RTI know that this is part of a sometimes lengthy process, and they take great pride in working through those issues to assist their clients to be the best versions of themselves. Recovery is a process that is not linear, especially within those that have mental health disorders, combined with drug and alcohol disorders. It's a process that involves set-backs and mistakes, but that ultimately results in learning experiences which then lead to growth and change.

Michael, former state reentrant at Renewal, is one of those success stories. His stay at Renewal was not without infractions, and at one point a brief absconsion. However, the progress that he made within treatment outweighed his indiscretions throughout his time with Renewal.

He first started treatment with Outpatient mental health. an angry, depressed person that engaged in drinking excessively to deal with both. He had no insight into the reasons behind his maladaptive behavior patterns, and was not sure that he wanted to change. However, with time and consistent therapy, he was able to work with his therapist to understand and identify a trauma history that he was suppressing with the alcohol abuse. Through education, trauma informed care, emotion management, and Cognitive Behavioral Therapy, he was able to improve his mood, develop healthy coping skills, and achieve several months clean from alcohol use. He showed a strong desire to improve his life, and assist others in doing the same. Michael was part of a pilot project with his therapist, where he told his story to peers in the inpatient program at Renewal. He taught them skills that he was learning in treatment as an assistance to the therapist. The reentrants responded well to him, and he and some of his peers became support for each other. Though he had some setbacks once he saw his time at Renewal coming to an end, he maintained an active role in treatment, showed up even when he was disappointed in himself, and worked through his issues.

He has since maxed out his sentence, is released from Renewal, has a job, his own apartment, and still attends treatment with Outpatient MH. He is a calmer, healthier, and happier person due to his hard work, and the hard work of his therapist.

PHASE ONE OPENED 11/5/2020

Pathway to Care and Recovery is a new program for residents of Allegheny County who have challenges around alcohol and/or other drugs and want information, support, and/or help. It is located at 326 Third Ave. Pittsburgh, PA, and is open 365 days per year/24 hours per day/7days per week.

It's a different kind of place:

- Where you don't run out of chances
- Where you can come when you may or may not be ready for treatment
- Where your voice is heard
- Where you can come when you're not sure where to turn

Who Is It For?

- Residents of Allegheny County ages 14 and up
- Family members, friends, and natural supports of those individuals who are challenged with a substance use disorder and need information or advice
- First responders who come upon someone in need of help or support
- Health and human service providers
- Schools, faith communities, advocates, and other community members

Program Services:

- Information
- Peer support
- Screening, level of care assessment, referral and support right up to admission
- MAT education
- Case management
- Connection to other human services through warm hand-offs

On-Site Team

A multidisciplinary staff who adhere to recovery-focused principles.

- Nurses-LPNs: Provide medical monitoring and MAT education
- Clinical Services Coordinators: Triage, screening for next steps
- Assessment Specialists: One on one engagement, assessment, referral
- Certified Recovery Specialists: Peer support throughout all services

Mobile Teams

- Two mobile teams see individuals in the community
- Teams consist of Drug and Alcohol Case Manager and Certified Recovery Specialist
- Respond to calls from police, emergency departments, crisis response teams, acute units, and family members or loved ones.
- Individuals served may or may not already be actively engaged in care
